BARREL RACE AGREEMENT - CAMBRIDGE SADDLE CLUB,INC. <u>PLEASE READ CAREFULLY</u>

ATTENTION PARENTS / LEGAL GUARDIANS OF MINORS: If the rider is a minor (less than 18 years of age), the parents/legal guardians (not the person bringing the minor) must agree to and sign this entry agreement form.

<u>RISKS</u>: There are inherent dangers, hazards and risks associated with equine (horse, pony, or mule) activities and injuries and damage resulting from these risks are a common occurrence. I understand and acknowledge that the equine activities bear certain known and unanticipated risks which could result in injury, death, illness or disease, and physical and/or mental damage to the rider, personal property, and to spectators and other third parties. The inherent risks involved in riding and working with equines, include but are not limited to:

- The propensity of any equine to behave in ways that may result in injury, harm, or death to persons on or around them and to potentially collide with, bite or kick other animals, people or objects.
- Falling from, or being thrown or bucked off by equines.
- The unpredictability of an equine's reaction to such things as sounds, sudden movement, tremors, vibrations, unfamiliar objects, persons or other animals, and hazards such as subsurface objects.
- The potential for other riders to behave in a negligent manner that may contribute to injury to themselves or others, including failing to act within their abilities to maintain control over an equine.
- Arenas, buildings, and grounds which can be slippery, muddy, wet, or contain or present other hazards causing slipping, falling, or other injury.

HELMETS REQUIRED FOR RIDERS UNDER AGE 18 AND STRONGLY RECOMMENDED FOR ALL: All riders under 18 years of age (minors) are required to wear an ASTM/SEI approved helmet. Helmets are strongly recommended for all riders.

I AGREE TO THE FOLLOWING: To participate at the <u>rider's own risk</u>. To indemnity and save/hold the Cambridge Saddle Club, Inc. and its' Officers, Members, Sponsors, and Agents (hereafter collectively referred to as "CSC") harmless against any and all claims, demands, and other forms of liability that may arise from any personal or property damage caused to and/or by the rider and/or equine. I hereby specifically forever waive and release "CSC" from any liability for injury arising out of the inherent risks from riding or participating at this event, as well as from the active negligence of "CSC". To abide by and follow any instructions given or rules established by "CSC", and the persons running the event. In the event of an emergency involving a minor rider where their parent/legal guardian is not present or cannot be reached, or in event an adult rider is incapacitated, I authorize "CSC" to provide emergency care for the rider. "CSC" is granted permission to use and/or publish the rider's photograph/image for marketing and/or publicity of the Cambridge Saddle Club, Inc. This document is a contract and if a lawsuit is filed against "CSC" for any injury or damage in breach of this contract, I will be responsible for any attorneys' fees and costs incurred by "CSC" in defending such an action. In the event any portion of this Agreement is determined to be invalid, illegal, or unenforceable, the validity, legality and enforceability of the balance of the Agreement shall not be affected or impaired in any way and shall continue in full legal force and effect.
